Before that, he held roles for an early stage technology company and for Safeguard Scientifics, Inc. (NYSE: SFE). Mr. Savitch began his career as a corporate associate at Willkie Farr & Gallagher.

Mr. Savitch received a B.A., *magna cum laude*, from the University of Vermont, and a J.D. from Harvard Law School. Among his philanthropic interests, Mr. Savitch volunteers his time to speak, to teach and to advise on entrepreneurship, law, compliance and governance. He currently serves on the Advisory Board for the Rutgers Center for Law and Corporate Governance and as a mentor for Mentor Connect, a program jointly sponsored by Ben Franklin Technology Partners and the Philadelphia Alliance for Capital and Technologies to provide guidance and support for local, early stage enterprises. He recently served as a regional and national judge for LawMeets®, a nationally recognized negotiation competition for law students and, prior to that, completed a year-long appointment as Adjunct Professor and Advisor to the John F. Scarpa Law and Entrepreneurship Center at the Villanova University Charles Widger School of Law.
